MEMBERSHIP APPLICATION PROCEDURE

Applicants are urged to take great care with the completion of the membership forms and to read through the specific requirements.

The Executive Committee may call the persons requesting membership cards for an interview prior to approving their membership.

Application Fee shall be submitted along with the Membership Application in the name of Naturals Farms Club & Resort LLP in the form of cheque or pay order. The Joining Fee shall be paid in accordance with the payment plan opted by the Applicant.

Documents required (Family Membership and Associated Membership):

Applies to all membership applications: Police Verification Report required.

- A fully filled and signed Membership Application along with the Application Fee.
- Copy of Family Registration Certificate of the Applicant.
- Copy of NTN certificate of the Applicant.
- Copy of National Identity Card of the Applicant, spouse, parents and children.
- Copy of marriage certificate. (Not required in case of valid FRC)
- Passport size photographs of the Applicant, spouse, parents and children.

Documents required (Corporate Membership)

- ⊙ A fully filled and signed Membership Application along with the Application Fee.
- ⊙ **For a Company (Private or Public):**
 - Certified true copy of the certificate of incorporation issued by the Securities and Exchange Commission of Pakistan.
 - Certified true copy of the latest Memorandum of Association and Articles of Association of the company.
 - Certified true copy of latest Form 9.
 - Copy of NTN Certificate.
 - Original Board Resolution authorizing the representative of the Company to execute the Membership Application.
- ⊙ **For a Partnership Firm:**
 - Certified true copy of Form C issued by the Registrar of Firms.
 - Certified true copy of the partnership agreement.
 - Copy of NTN Certificate.
 - Original Partner's Resolution authorizing the representative of the firm to execute the Membership Application.
- ⊙ 2 passport size pictures of each nominee with White Background.
- ⊙ Copy of CNIC or NICOP of each nominee.

TERMS AND CONDITIONS

These Terms and Conditions outline the key policies, privileges, responsibilities, and restrictions governing membership at Naturals Club & Resort ("the Club"). The Applicant acknowledges that these terms and conditions are in addition to the rules, regulations and Bylaws of the Club, which shall prevail in case of any conflict. The Club reserves the right to amend, modify, or supplement any rules, policies, charges, or operating hours at its discretion, and Members will be notified via Bulletin Board, email, or the Club's website.

Membership grants a revocable, non-transferable, and non-equity license to use the Club's facilities. It does not confer ownership, voting rights, or any financial interest in the Club, Naturals Farms Club & Resort LLP, or its assets. The Application for Membership is subject to approval, and the Club reserves the right to accept or reject any application at its sole discretion. In case of non-acceptance, the Application Fee will be refunded. Duly completed applications will be acknowledged, and the Applicant (along with their spouse) may be required to attend an interview, as determined by the Executive Committee.

Upon issuance of a Provisional or Regular Membership, the Member shall be liable for all fees and charges as determined by the Club, regardless of usage. Membership Fees, including the Application Fee and Joining Fee, are non-refundable except as explicitly stated in the Bylaws. The Security Deposit shall be refunded only in case of voluntary retirement or termination of membership by the Club, subject to deductions for outstanding dues, damages, or penalties. The Club may utilize the Security Deposit for its business purposes, including development, operations, and management, at its discretion.

Membership may be suspended or terminated for violations of Club policies, non-payment of dues, or behavior detrimental to the Club. The Club reserves the right to terminate a membership at its discretion, in which case the Membership Fee shall be refunded. However, no refund will be given if the termination results from a violation of Club policies. The Club's decision on suspension or termination shall be final and binding.

A valid membership card is required for entry and must be presented upon request. Lost or stolen cards must be reported immediately, and a replacement fee will be charged.

Membership cards are strictly non-transferable and may not be used by non-members. The Club reserves the right to restrict facility access due to maintenance, events, or policy violations.

All Members, their families, and guests must conduct themselves respectfully at all times. Members are responsible for their own behavior and that of their family and guests. Strictly prohibited conduct includes loud, disruptive, or offensive behavior; use of foul or abusive language; harassment or disrespect towards staff or other members; unauthorized photography or recording of others; bringing or consuming alcohol, drugs, or intoxicating substances; carrying weapons or dangerous objects; smoking outside designated smoking areas; bringing pets onto Club premises; loitering in parking areas; and unauthorized movement or rearrangement of Club property. Disciplinary actions for violations may include verbal or written warnings, fines, suspension of privileges, or permanent termination of membership.

The Club is a private facility exclusively for Members. Guests are allowed only in designated areas and must be accompanied by the Member at all times. A maximum of two (2) guests per visit is allowed, subject to applicable guest fees. Guests must register at the main desk and provide valid ID upon arrival. Only the Member or their Spouse may introduce guests; Dependent Children are not permitted to bring guests. Guests cannot access sports, recreational, or pool facilities and must adhere to all Club policies. Any guest causing a nuisance will be removed immediately. Individuals expelled, rejected for membership, or under suspension are prohibited from entering as guests. The Club reserves the right to permanently ban any guest without prior notice.

All membership dues and fees must be paid within seven (7) days of invoicing. Late payments will incur penalties as determined by the Club. Non-payment for over two (2) months may result in suspension or termination of membership. The Club reserves the right to revise fees and charges as deemed appropriate.

Members and guests must adhere to the Club's dress code at all times. Inappropriate attire may result in denied entry to the Club or its facilities. Strictly prohibited clothing includes items with offensive language or slogans, excessively worn or revealing attire, open-toed footwear (e.g., sandals, slippers, flip-flops), and shawls for men. Facility-specific attire requirements include smart casual wear for dining areas, proper sportswear for sports facilities, and appropriate swimwear for the pool.

Each Member may bring only one (1) accompanying staff member (e.g., driver) to the parking area. Accompanying staff must remain in the vehicle or designated waiting areas and are strictly prohibited from accessing Club facilities. Blocking entrances, driveways, or walkways is strictly prohibited, and violators' vehicles will be towed at their expense.

Weapons of any kind are strictly prohibited on Club premises. Any Member or security personnel carrying firearms must deposit them at the designated storage facility upon entry. Non-compliance will result in immediate removal from the premises and possible membership suspension.

CCTV cameras operate on Club premises for security purposes. The Club may use photos/videos of Members at events for promotional purposes, but Members may opt out in writing if they do not consent to image use. Unauthorized photography or video recording of other Members is strictly prohibited.

Members use Club facilities at their own risk. The Club is not responsible for injuries, health issues, or medical complications. In case of an emergency, Members must follow staff instructions and evacuation procedures as directed.

The Club is not liable for lost, stolen, or damaged property. Members fully indemnify the Club against any claims arising from their actions or those of their guests. The Club reserves the right to close facilities for maintenance or events without prior notice.

All complaints must be submitted in writing to the General Manager via the suggestion box, email, or formal letter. The Club will review complaints at its discretion, and all disputes will be resolved by Club management, whose decision shall be final.

By accepting a Membership Card and using Club facilities, the Member agrees to comply with the Club’s Bylaws, rules, regulations, and policies, including any amendments or updates. Members are responsible for reviewing updates communicated via email, the Club’s website, or posted notices.

I acknowledge that the privileges granted are subject to the discretion of Club management and that non-compliance may result in disciplinary action, including suspension or termination of membership.
